Solar Ordinance

Ms. Lillibridge stated that this is from the Michigan Planning and Enabling Act 125.3815, Sec. 15(4c).

Motion by Lessard, supported by Cuppen to accept the Planning Commission Bylaws for 2023.

Chairman Wilson shared that he had a Zoom meeting with Adam Young on Mar. 1 concerning updating the Master Plan. Adam Young will put a proposal together for the Master Plan.
